## 4. FIRST AID MEASURES

### First Aid Procedures:

<b>Inhalation:</b>	Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. WARNING! ## 5. FIREFIGHTING MEASURES

Sealed containers may explode when heated or involved in fire. Material is sensitive to static discharge. Vapors may travel considerable distance to source of ignition and flash back. ## 6. ACCIDENTAL RELEASE MEASURES

<b>Methods for Containment:</b>	Eliminate all sources of ignition. Stop the flow of material if this is without risk. Prevent entry into waterways, sewer, basements, or confined areas.
