### 4. FIRST AID MEASURES

### **First Aid Procedures:**

**Inhalation:** Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial

### 5. FIREFIGHTING MEASURES

### 6. ACCIDENTAL RELEASE MEASURES

### 7. HANDLING AND STORAGE

**Handling:** Do not handle, store, or open near an open flame, sources of heat, or sources of ignition.

Wear personal protective equipment (see Section 8). Use only in well-ventilated areas. Provide sufficient air exchange and/or exhaust in work areas. Avoid contact with skin, eyes, and clothing. Do not breathe vapors or spray mist. Do not ingest. When using, do not eat, drink, or smoke. Take precautionary measures against static discharge. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from incompatible materials (see Section 10).
