4. FIRST AID MEASURES

First Aid Procedures:

Inhalation: Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. WARNING! It may be hazardous to the person providing aid to give mouth-to-mouth resuscitation when the inhaled or ingested material is toxic, infectious, or corrosive. Do not use mouth-to-mouth resuscitation if victim ingested or inhaled the substance; induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Skin Contact: Remove contaminated clothing and shoes. Wash skin with plenty of water for at least 15 minutes. Wash clothing before reuse. Get medical attention if symptoms occur.

Eye Contact: Check for and remove contact lenses if present and easy to do. Immediately flush eyes with gentle but large stream of water for at least 15 minutes, lifting lower and upper eyelids occasionally. Get medical attention if symptoms occur.

Symptoms and Effects: Irritation, unconsciousness, visual disturbances, drowsiness, dizziness, nausea, vomiting, abdominal pain, skin dryness, skin redness. May be harmful if swallowed, inhaled, or exposed to the skin or eyes. Causes irritation to the eyes, skin, respiratory tract, and gastrointestinal tract. May cause drowsiness or dizziness if inhaled or absorbed into the blood stream. May affect the respiratory system and mucous membranes. Prolonged or repeated exposure may cause liver, kidney, and central nervous system effects. Prolonged or repeated exposure may also cause adverse reproductive effects and dermatitis.

5. FIREFIGHTING MEASURES

Suitable Extinguishing Media: Water spray, dry powder, alcohol resistant foam, carbon dioxide.

Unsuitable Extinguishing Media: Do not use a solid (straight) water stream, as it may scatter and spread fire.

**Hazardous Combustion
Products:** Carbon oxides.

Specific Hazards: Highly flammable. Vapors may cause flash fire or ignite explosively. Burns vigorously if ignited easily by heat, sparks, or flames. Material may burn with an invisible flame. Sealed containers may explode when heated or involved in fire. Material is sensitive to static discharge. Vapors may travel considerable distance to source of ignition and flash back. Vapor from the solvent may accumulate in container headspace resulting in flammability hazard.

**Special Protective Equipment/
Precautions for Firefighters:** As in any fire, wear MSHA/NIOSH-approved (or equivalent), self-contained, positive-pressure or pressure-demand breathing apparatus and full protective gear. Use water spray to cool unopened containers. Move containers from fire area, if you can do so without risk. This material may evaporate and leave a flammable residue if spilled. In the event of fire and/or explosion, do not breathe fumes.

6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions and
Protective Equipment:** Ventilate area of leak or spill. Isolate hazard area and keep unnecessary and unprotected personnel away from the area of the leak or spill. Keep upwind. Keep out of low areas. Wear appropriate personal protective equipment (see Section 8). Remove all sources of ignition. Pay attention to flashback. Take precautionary measures against static discharge. All equipment used when handling the product must be grounded. Use spark-proof tools and explosion-proof equipment. Avoid contact with eyes, skin, and clothing.

Emergency Procedures: In case of chemical emergency, or if unsure how to address an accidental release, consult a professional (see Section 1).

Methods for Containment: Eliminate all sources of ignition. Stop the flow of material, if this is without risk. Prevent entry into waterways, sewer, basements, or confined areas. Dike the spilled material where possible. Product should not be released to the environment. Contain and recover liquid when possible.

Methods for Cleanup: Absorb spill with an inert material (e.g. vermiculite, dry sand, earth, cloth, or fleece) and place in a non-combustible container for reclamation or disposal. Do not flush to sewer.

Clean contaminated surface thoroughly. Never return spills in original containers for reuse.
Clean up in accordance with all applicable regulations.

7. HANDLING AND STORAGE

Handling: Do not handle, store, or open near an open flame, sources of heat, or sources of ignition. Wear personal protective equipment (see Section 8). Use only in well-ventilated areas. Provide sufficient air exchange and/or exhaust in work areas. Avoid contact with skin, eyes, and clothing. Do not breathe vapors or spray mist. Do not ingest. When using, do not eat, drink, or smoke. Take precautionary measures against static discharge. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from incompatible materials (see Section 10). Handle in accordance with good industrial hygiene and safety practice. Wash thoroughly after handling. Containers of this material may be hazardous when empty, as they retain product residues. Observe all warnings and precautions listed for this product.

Storage: Store in a cool, dry, ventilated area. Store in a segregated and approved area away from heat, sources of ignition, and incompatible materials (see Section 10). Store in original container. Keep containers tightly closed and upright. Keep away from food, drink, and animal foodstuffs. Keep out of the reach of children. Ground container and transfer equipment. Comply with all national, state, and local codes pertaining to the storage, handling, dispensing, and disposal of this product.
