4. First-aid measures

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a poison center or doctor/physician.

To prepare the antidote, make a solution using 100 mL of 100-proof ethyl alcohol (grain alcohol) in 2000 mL of water and give 1.5 mL/kg of body weight, or 100 mL for an average adult. Following this, at 2 hour intervals for 4 days, give the antidote (0.5-1.0 mL/kg of body weight, orally or intravenously) to reduce the metabolism of the methanol and to allow time for its excretion. Blood ethanol levels should be 1.0-1.5 mg/mL.
